

Immigration Fees

Hourly rate: £160

The exact number of hours it will take depends on the circumstances in your case. Such as:

- Supporting evidence that we need to consider and that you provided
- If documents or information is missing and how long it will take to obtain this
- Whether you are applying with other dependants (Their will be an additional charge for dependants)

If you are able to provide sufficient evidence at our first meeting and clearly meet the applicable immigration rules, the cost is likely to be at the lower end of this range.

The costs quoted do not include any appeal fees or court costs for making this application. You will therefore need to pay the application fee and/or Immigration Surcharge fees (If appeal is applicable) as part of the application process.

Independent expert reports e.g. medical experts are not required in many cases. We will let you know as soon as possible if we consider an expert report is necessary.

Disbursements such as Barrister fees are also not included and you will be advised a Barrister fee before the firm will instruct one on your behalf.

The work will involve:

- Advising and discussing your circumstances in detail and advising whether this is the most appropriate application for you to make and what other options you have and the chance of success
- Taking your instructions and giving you advice whether the criteria is met
- If you do not fulfill our requirements, whether this is detrimental and how or if you can still proceed with your case
- Considering your supporting evidence that you have provided
- Where necessary, helping your appeal obtain further evidence (such as medical records & translations)
- Preparing your application and submitting it on your behalf of the appeal
- Giving you advice about the outcomes of the application and any further steps you need to take or are available to take
